Subject of the Disclosure	Labor actions in some automotive suppliers operating in Bursa region, have caused interruption in parts supply to our Gölcük and Yeniköy Plants in Kocaeli campus. As a result manufacturing operations in Gölcük and Yeniköy Plants have been temporarily suspended
Information on suspended operations	Manufacturing at Gölcük and Yeniköy plants
Reason of the suspension	Interruption in parts supply due to labor actions in some automotive suppliers operating in Bursa region
As of date	20 May 2015
Impact on Production	The annual production plan will be revised to offset the production loss once the parts supply issue is resolved.
Impact on Sales	No impact is expected on sales at this point
Share in total production and sales	All manufacturing operations except İnönü plant
Number of workers subject to contract cancellation	None

Actions Taken by Company Management	Blue collar workers have been given vacation except maintenance
What is needed for the production to restart	Production will start when the labor action in supplier companies are resolved and parts supply is reinstated.

Labor actions in some automotive suppliers operating in Bursa region, have caused interruptions in parts supply to our Gölcük and Yeniköy Plants in Kocaeli campus. Due to the parts supply shortage, effective from May 20<sup>th</sup>, 2015 Wednesday, manufacturing operations in Gölcük and Yeniköy Plants have been temporarily suspended. Production will start when the part supply problem is resolved.
