After the Covid-19 pandemic, which has affected the whole world since the first quarter of 2020, due to the increasing demands of many industries for electronic components (microchips), there are problems in the supply of in-vehicle electronic components, which have been used more intensely in the automotive sector in recent years. Our main partner, Ford Motor Company, works with its global suppliers to ensure the efficient use of materials belonging to electronic components by giving priority to the solution of the problem and main production lines. As Ford Otosan, necessary plans are made with our suppliers, and the possible effects of supply shortages are minimized.

In this context, production will be suspended in our Kocaeli Plants for six days from April 3, 2021 to April 9, 2021, due to the restrictions in the supply of some parts, where microchip use is intensive, from abroad.

During this production interruption, which is not expected to affect our production and sales forecasts for the year 2021 that has been disclosed to the public, maintenance works and rearranging production lines in preparation for new investments will continue.
