

# DATA SUBJECT APPLICATION FORM (IN ACCORDANCE WITH THE PERSONAL DATA PROTECTION LAW NO. 6698) (FOR THE APPLICATIONS OF DATA SUBJECT TO THE CONTROLLER¹)

#### **GENERAL EXPLANATION:**

Personal data subjects, (hereinafter referred to as "data subject") defined as the data subject in the Personal Data Protection Law No. 6698 ("Law"), are granted certain rights regarding the processing of their personal data in Article 11 of the Law.

Pursuant to the Article 13/1 of the Law and the Article 5 of the Communiqué on Principles and Procedures for the Request to Data Controller, the applications regarding these rights to be made to Ford Otomotiv Sanayi Anonim Şirketi, ("Company") who is the data controller, must be submitted in writing or by other methods determined by the Personal Data Protection Board ("Board").

Within this framework, the applications to be made to Company "in writing" must be submitted with a printout of this form and submitted to us by one of the application methods set out below.
